

# **POLYGLUE** (ADHESIVE & BASIC COATING)



# PRODUCT DESCRIPTION

The POLYGLUE is a resinous, fiber reinforced adhesive cementitious mortar. Used as an adhesive and basic coating for bonding and coating (reinforced with fiberglass mesh) plates expanded (EPS), extruded polystyrene (XPS), Graphite polystyrene and mineral wool.

## APPLICATION CONDITIONS

Do not apply at temperatures below 6°C and above 40°C and at relative humidity above 80%. Adverse conditions in the application can alter the final properties of product.

## APPLICATION INSTRUCTIONS

For proper use of the product should the coating surface be cleaned from dust, grease, oil, paint, loose materials etc.

1) Mix the adhesive **POLYGLUE** with cold clean water in a clean container, using a low speed mixer (<600 rpm). 2) After the mixture was homogenized leave 5-10 minutes to mature and stir again. 3) Apply with a trowel for spot welding or spatula continuous welding polystyrene plates or normalization.

### APPLICATIONS TOOLS

#### Notched spatula, trowel

The adhesive is applied with a notched spatula or trowel to the desired point. Do not empty washings into the groundwater.



# **STORAGE**

At least 12 months into closed bags and dry areas.

# PACKAGING

It is delivered in plastic containers of 25Kg
